For the quarter ended September 30, 2019, the Company achieved net revenue of Rs.570.63 crore as against Rs.394.41 crore in the previous quarter, an increase of 44.67% over previous quarter of the corresponding year.

The operational EBIDTA for the quarter was Rs.0.44 crore as compared to Rs.10.88 crore in the corresponding quarter of last year. The Company has reported a net loss of Rs.44.12 crore during the quarter ended September 30, 2019 as compared to net loss of Rs.32.62 crore in corresponding quarter of last year due to squeezed margins in Industry at large.
